Sewer Adjustment Request

If you have experienced a leak on your property and it has impacted your utility bill, please complete the attached Sewer Adjustment Request Form. After you have repaired the leak, please provide the following information to document your repairs and cost.

- A completed Sewer Adjustment Request Form
- A copy of your plumber's bill/letter from the homeowner showing they repaired the leak
- All receipts for materials

Customers are limited to one leak adjustment every 2 years, with a maxim um adjustment amount of \$50 per adjustment. The Water Works and Sewer Board of the Cit y of Prichard encourages its customers to be conscientious in maintaining their residential and commercial plumbing fixtures. The responsibility of repairing and replacing defective plumbing on private property is the sole responsibility of the owner.

- Adjustment shall I not be considered for disputed bills that are over six months old.
- Your account must remain current during the review process.
